

# BESSI INDIVIDUAL PRACTITIONER LICENSING AGREEMENT

## IMPORTANT NOTICE TO LICENSEE:

THIS AGREEMENT GOVERNS YOUR USE OF THE BESSI MATERIALS. BY PAYING THE INVOICE REFERENCING THIS AGREEMENT, YOU (“LICENSEE”) EXPRESSLY ACCEPT AND AGREE TO BE BOUND BY THESE TERMS. IF YOU DO NOT AGREE TO THESE TERMS, DO NOT PAY THE INVOICE AND DO NOT USE THE BESSI MATERIALS.

This Individual Practitioner Licensing Agreement (the “Agreement”) is entered into between **BESSI Lab LLC**, an Illinois, USA, limited liability company (“Licensor”), and the individual or entity identified as the Customer on the associated invoice (“Licensee”).

The “**Effective Date**” of this Agreement shall be the date on which the Licensee submits payment for the License Fee.

## 1. Definitions

- “**BESSI Materials**” refers to the Behavioral, Emotional, and Social Skills Inventory items, scales, scoring algorithms, manuals, feedback reports, and the online assessment platform provided by Licensor.
- “**Individual Client**” refers to a single person with whom the Licensee has a direct, one-on-one professional relationship for the purpose of counseling, coaching, or therapy.
- “**Commercial Product**” refers to any course, workshop, training program, book, webinar, or scalable product created by the Licensee for sale to the general public or organizations.

## 2. Grant of License

Subject to the terms and conditions of this Agreement and the payment of the License Fee, Licensor hereby grants to Licensee a **limited, non-exclusive, non-transferable, non-sublicensable, revocable license** to:

1. Administer the BESSI to Individual Clients via manual paper forms or the Licensor’s authorized online assessment tool.
2. Generate and interpret BESSI feedback reports for use specifically within the context of private coaching or counseling sessions with Individual Clients.
3. Use the BESSI framework to guide professional interventions with Individual Clients.

### 3. Permitted Uses

The Licensee is authorized to use the BESSI Materials solely for the following purposes:

- **Assessment:** Assessing the skills of Individual Clients to inform coaching or therapeutic goals.
- **Progress Monitoring:** Tracking the development of skills in Individual Clients over time.
- **Feedback:** Reviewing results privately with the Individual Client.
- **Documentation:** Including psychological reports and case notes.

### 4. Prohibited Uses (Commercial Restrictions)

**CRITICAL NOTICE:** This license is strictly for individual practitioner use. It does **NOT** grant rights for broad commercial exploitation. The following uses are strictly prohibited under this Agreement and require a separate **BESSI Commercial License**:

1. **Courses and Trainings:** Licensee may **not** incorporate the BESSI into paid courses, group workshops, masterclasses, or certification programs where the BESSI framework or assessment constitutes a substantial portion of the curriculum or value proposition (defined as more than 10% of presentation time or the reproduction of more than 1 BESSI figure/table).
2. **Product Creation:** Licensee may **not** create or sell books, workbooks, apps, or other derivative products based on the BESSI content, items, or scales.
3. **White Labeling:** Licensee may **not** rebrand the BESSI or remove copyright notices, trademarks, or attribution to BESSI Lab LLC or its creators (Christopher J. Soto, Christopher M. Napolitano, and Brent W. Roberts).
4. **Organizational Consulting:** This license does not cover large-scale administration to employees of a corporation or students of a school, district, college, university, or other educational institution (institutional licensing is required for such use).

### 5. Fees and Payment

- **Annual License Fee:** The fee is **\$300.00 USD**, or as stated on the invoice provided by Licensor.
- **Payment as Acceptance:** Payment of the invoice constitutes the Licensee's electronic signature and acceptance of this Agreement.
- **Renewal:** This license is valid for one (1) year from the Effective Date. It may be renewed annually upon payment of the then-current Annual License Fee.

### 6. Intellectual Property Ownership

Licensee acknowledges that BESSI Lab LLC and the original creators (Soto, Napolitano, and Roberts) retain all right, title, and interest in and to the BESSI Materials, including all copyrights, trademarks, trade secrets, and other intellectual property rights. Nothing in this Agreement conveys ownership rights to the Licensee.

## 7. Data Privacy and Ethics

1. **Professional Standards:** Licensee agrees to administer the BESSI in accordance with all applicable ethical standards of their profession (e.g., APA, ACA, ICF) and applicable laws.
2. **Client Consent:** Licensee is solely responsible for obtaining necessary informed consent from Individual Clients regarding the administration of the assessment and the processing of their data.
3. **Online Tool:** If utilizing the BESSI online assessment tool, Licensee agrees to the Terms of Service and Privacy Policy of that specific platform.

## 8. Warranties and Limitation of Liability

- **As-Is Basis:** The BESSI Materials are provided “AS IS” without warranty of any kind, express or implied.
- **Limitation of Liability:** In no event shall Licensor be liable for any indirect, incidental, special, or consequential damages arising out of the Licensee’s use of the BESSI. The Licensor’s total liability under this Agreement shall not exceed the amount of the License Fee paid by Licensee during the twelve (12) months preceding the claim.
- **Professional Judgment:** Licensee acknowledges that the BESSI is a tool to support, not replace, professional judgment. Licensor is not responsible for decisions made by Licensee based on BESSI scores or feedback.

## 9. Term and Termination

- **Term:** This Agreement is effective for one (1) year from the date of payment.
- **Termination for Breach:** Licensor may terminate this Agreement immediately upon written notice if Licensee breaches any material term (specifically Section 4 regarding Commercial Restrictions).
- **Effect of Termination:** Upon termination, Licensee must immediately cease all use of the BESSI Materials and destroy any physical copies in their possession.

## 10. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the **State of Illinois, USA**, without regard to its conflict of laws principles.
